

IPSA Andhra Pradesh chapter Award for best M V Sc/M.Sc. Thesis 2018: Terms and Conditions

1. Name of the Award

“IPSA Andhra Pradesh chapter Award” for the best M.V.Sc. /M.Sc. thesis in the field of “Poultry Science” for the year 2018.

2. Sponsor

Andhra Pradesh chapter of IPSA, Hyderabad.

The award will be conferred in the **IPSACON 2018 during 15-17 Nov., 2018 being organized at Division of Animal Science, ICAR-Central Inland Agricultural Institute (ICAR-CIARI), Port Blair**

3. Objectives of the Award

- To recognize the outstanding original research done by Master degree students in the discipline of Poultry Science
- To encourage high quality post-graduate research in priority areas of poultry science

4. Nature of the Award

- This award is meant exclusively for Master thesis in Poultry Science discipline from any Indian University/Research Institution. **Every year one MVSc./M.Sc thesis** will be awarded. The individual award will consist of a citation and medal made of silver having gold plating.

5. Eligibility

- 5.1 For the award of 2018, the thesis approved during January to December, 2017 will be considered.
- 5.2 The thesis should be a part of the Masters programme that leads to MVSc. /M.Sc. degree in Poultry Science.
- 5.3 The research work must be original and must have a direct bearing on some relevant aspects of the Poultry production, health or management systems.
- 5.4 The results obtained should have the potential of enhancing the production/productivity/sustainability of the Poultry production/management system or substantially advance our knowledge.
- 5.5 Should have published/accepted research paper(s) in a peer reviewed journals.

6. Administration of the Award

There shall be a Judging Committee consisting of 5 expert members from different disciplines of poultry sciences for evaluation of entries.

7. Evaluation Criteria

- 7.1 The thesis to be evaluated will be awarded marks in ratio of 70 (for Thesis): 20(for Publication/patents applied) :10 (for academic qualification)

- 7.2 The thesis will be evaluated on following basis
- Conceptual clarity, Scientific, technological and socio-economic relevance and priority of the research problem
 - Compilation, analysis and interpretation of existing literature, quality of illustrations and photographs
 - Organization of research work. Complementarily of the various experiments and investigations and their integration into a logical plan of work
 - Conduct of the research programmes: Scientific soundness and technological modernity of the experimental methods and logical planning
 - Scientific validity and accuracy of the analysis of experimental data
 - Principal findings: To what extent do they meet the objectives of the research programme
 - In what way the findings constitute a significant advance in our knowledge and understanding or help improve productivity and sustainability
- 7.3 Publication will be awarded marks on their quality as judged by the NAAS rating
- 7.4 Academic qualification will be evaluated based on marks obtained /OGPA in graduation and post graduation.

8. Procedure

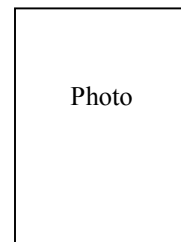
Applications for the award made in the prescribed application proforma obtainable free of cost from the IPSA web site (www.ipsa-cari.org.in), IPSA Head Office and also given below, will be accepted on or before the prescribed last date, **i.e. October 15, 2018**. The duly filled “Proforma of Application” may be sent to General Secretary/ Joint Secretary of IPSA at CARI, Izatnagar. The Judging Committee will screen the Applications, identify the outstanding entries, and make recommendations to the IPSA along with the draft citations.

9. Presentation

The presentation of award will be made in the IPSACON 2018 during November 15-17, 2018 being organized at **Division of Animal Science, ICAR-Central Inland Agricultural Institute (ICAR-CIARI), Port Blair**. The awardees would give a presentation of about 10 min. on salient achievements of his work to the audience consisting of eminent poultry educationist and researchers and stalwarts in the other fields of agricultural/animal Science.
